## PROMOTION TERMS AND CONDITIONS

These Terms govern the Promotion and apply to all persons (referred to in these Terms as “**you**” or “**your**”) who are eligible to and participate in the Promotion.

We, Toyota (G.B.) PLC, are the promoter of the Promotion. Toyota (G.B.) PLC (referred to in these Terms as “**TGB**”, the “**Promoter**”, “**us**”, “**we**” or “**our**”) is a company incorporated in England and Wales with registration number 00916634.

By participating in the Promotion, you are entering into a contract with us, and you agree that these Terms will apply. If you do not agree with these Terms, you should not participate in the Promotion. **Your attention is drawn specifically to section 7 (Limitation of Liability), because it limits our liability to you for our breach of these Terms or otherwise in connection with the Promotion.**

### 1. THE PRIZE

1.1 The Prize is as follows:

- 1.1.1 1 x LEGO® Technic Fast & Furious Toyota Supra MK4 (42204) - A detailed LEGO® Technic model inspired by the iconic Toyota Supra MK4.
- 1.1.2 £100 Toyota Trade Parts Credit - The credit will be applied directly to the Winner's Toyota Trade Parts account. The credit can be used when ordering genuine Toyota parts via the Toyota Trade Parts website by logging into your account.
- 1.2 There is no cash alternative. The Promoter reserves the right to substitute the Prize with an alternative Prize of equal or higher value if it is necessary to do so.
- 1.3 In relation to the Prize outlined in clause 1.1.1, the Promoter or Administrator shall not be responsible for the condition, completeness, or content of the Prize. The Promoter and Administrator has no control over the provision or quality of the Prize and disclaims any liability for any defects, omissions, or issues arising in connection therewith.
- 1.4 The Prize is not negotiable, transferable or exchangeable.

### 2. ENTRY PERIOD

The Promotion will run from 00:00 on Wednesday 28th January 2026 (“Opening Date”) to 23:59 on Tuesday 31st March 2026 (“Closing Date”) inclusive. All Promotion entries must be received by the by the Closing Date. All Promotion entries received after the Closing Date are automatically disqualified.

### 3. ELIGIBILITY

- 3.1 Subject to any other provisions of these terms and conditions, this Promotion is open to all UK (including Northern Ireland) Independent Garages and Bodyshops who are new members of the Toyota Trade Parts Club. For avoidance of doubt, existing members and entrants outside of the Closing Date will not be included in the Promotion.
- 3.2 Registration and acceptance for membership of the Toyota Trade Club is subject to review by Toyota. Such decision shall be final, and no correspondence shall be entered into.
- 3.3 In entering this Promotion, you confirm that your business is eligible to do so and eligible to claim the Prize you may win. The Administrator may require you to provide proof that you are eligible to enter this Promotion.
- 3.4 The Administrator will not accept entries that are:
  - (a) automatically generated by computer or created by artificial intelligence (including but not limited to chatbots such as ChatGPT or similar software applications);

- (b) completed by third parties or in bulk;
  - (c) illegible, have been altered, reconstructed, forged or tampered with;
  - (d) photocopies and not originals;
  - (e) incomplete;
  - (f) false, misleading, fraudulent, derogatory, offensive or otherwise contrary to the spirit in which the Promotion is conducted.
- 3.5 There is a limit of one entry to this Promotion per eligible business. Entries on behalf of another Independent Garage or Bodyshop will not be accepted, and joint or multiple submissions are not allowed. Entries submitted via any automated or similar systems will not be accepted.
- 3.6 The Promoter and Administrator reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of this Promotion.

#### **4. HOW TO ENTER**

- 4.1 The Promotion will run from 00:00 on Wednesday 28th January 2026 (the "Opening Date") to 23:59 on Tuesday 31st March 2026 (the "Closing Date") inclusive.
- 4.2 All entries received after the Closing Date are automatically disqualified.
- 4.3 To be eligible the participant must be:
- (a) an Independent Garage or Bodyshop;
  - (b) UK company including Northern Ireland; and
  - (c) be a new member of the Toyota Trade Parts Club.
- 4.4 An Independent Garage means a business that operates independently of any OEM and/or vehicle retail outlet or group, whose main business derives solely from vehicle repair and maintenance services included but not limited to MOT testing, vehicle servicing, maintenance and repairs.
- 4.5 A Bodyshop means a business whose activities derive solely or substantially from vehicle accident repair whether or not that business is independent or associated with an OEM, vehicle retailer or repairer and/or insurer.
- 4.6 All new members of the Toyota Trade Parts Club will be automatically entered into the prize draw, no action from the member is required to enter. Applications are subject to Toyota approval and must be approved before entering this Promotion.
- 4.8 It is the responsibility of the Participants to ensure that all information provided is accurate and complete.
- 4.9 No purchase necessary. There is no charge to participate.
- 4.10 By participating in this Promotion, you are agreeing to be bound by these terms and conditions.

#### **5. WINNER**

- 5.1 The Administrator will draw one (1) entry of the Prize at random from all eligible entries to win the Prize (the "Winner").
- 5.2 The decision of the Administrator is final, and no correspondence or discussion will be entered into.
- 5.3 The Administrator will contact the Winner as soon as practicable after 13th April 2026

using the email address provided upon application to the Toyota Trade Parts Club to notify them that they are a Winner of the Prize. It is the responsibility of the participant to ensure they check their "junk" folder for this notification.

- 5.4 If the Administrator is unable to contact the Winner within 14 days from the first attempt to contact the winner, a new winner will be selected at random from all remaining eligible entries. This process will be repeated until the Prize is fulfilled.
- 5.5 By entering this promotion, Winners agree that the Promoter may use their business name in media and marketing materials, without additional compensation, unless prohibited by law. Winners may be asked to participate in reasonable publicity related to the promotion.

## **6. CLAIMING THE PRIZE**

- 6.5 The Administrator will make all reasonable efforts to contact the Winner. If the Winner cannot be contacted, or is not available, or has not claimed their Prize within 4 (four) days of the date they are contacted, the Administrator reserves the right to offer the Prize to the next eligible participant selected from the entries that were received before the Closing Date. For the avoidance of doubt, in circumstances where a replacement Winner is selected in accordance with this condition 6.4, the Administrator shall advise within the notification e-mail the number of days for the replacement Winner to claim the Prize.
- 6.6 The Promoter and Administrator does not accept any responsibility if you are not able to take up the Prize.
- 6.7 The Prize cannot be claimed by a third party on your behalf.

## **7. LIMITATION OF LIABILITY**

- 7.1 The Promoter will not accept:
  - 7.1.1 responsibility for Promotion entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any postal failure (if applicable), equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind; or
  - 7.1.2 proof of posting (if applicable) or transmission as proof of receipt of entry to the Promotion.
- 7.2 Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the Winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the Prize except where it is caused by the negligence of the Promoter, its agents or distributors. If applicable. Your statutory rights are not affected.
- 7.3 The Promotor will not be in breach of these Terms, nor be liable for any failure to comply with any of our obligations in connection with the Promotion, if such breach or failure is caused by an event outside of our reasonable control. Events outside of our reasonable control include, but are not limited to, acts, omissions or failure of third parties, acts of

god, natural disasters, fire, flood or collapse of buildings, epidemic or pandemic, terrorist attack, war, preparation for war or armed conflict, imposition of sanctions, any law or action taken by a government or public authority, IT and data security incidents (such as malware or ransomware attacks, denial of service attacks or other types of cyber attack), or interruption or failure of utility or telecommunications service. If we are unable to run the Winner selection process within the period specified due to an event outside of our reasonable control, we will run the Winner selection process once we are no longer inhibited by such an event.

## **8. DATA PROTECTION AND PUBLICITY**

- 8.1 The Promoter will only process your personal information as set out in the <https://www.toyota.co.uk/footer/privacy-policy> and to the extent necessary to administer this Promotion, including in the announcement of Winners, see section 5 of these Terms. Participants' personal data will be retained only for as long as necessary to administer the Promotion, notify Winners, and comply with legal obligations. After the conclusion of the Promotion and the distribution of the Prize, personal data will be securely deleted unless retention for a longer period is required by law.
- 8.2 By participating in the Promotion, you consent to the processing of your personal data for the purposes of the administration of this Promotion, including the use of third party data processors where required. Your personal data will be processed solely for the purpose of facilitating the Promotion and in accordance with our instructions and will not be shared with third parties for their own marketing purposes without your explicit consent. All third-party processors engaged in connection with the Promotion are contractually bound by data protection obligations consistent with those of the Promoter. - 9.2 The Promotion may be varied, amended, extended or withdrawn at any time.
- 9.3 No third party can enforce these Terms.
- 9.4 In the event of a conflict between these Terms and any other Terms or instructions related

to this Promotion, these Terms take precedence.

- 9.5 These Terms are governed by English law and are subject to the exclusive jurisdiction of the English Courts.
- 9.6 The Promoter may transfer our rights and obligations under these Terms and the Promotion to any of our affiliated companies, or to any third party in connection with our business.
