PROMOTION TERMS AND CONDITIONS

These Terms govern the Promotion and apply to all persons (referred to in these Terms as “you” or “your”) who are eligible to and participate in the Promotion.

We, Toyota (G.B.) PLC, are the promoter of the Promotion. Toyota (G.B.) PLC (referred to in these Terms as “TGB”, the “Promoter”, “us”, “we” or “our”) is a company incorporated in England and Wales with registration number 00916634.

1. THE PRIZE

There are sixteen (16) Prizes available. Each Prize consists of two VIP Hospitality tickets to a British Touring Car Championship (‘BTCC’) event, allocated as follows:

- 1.2 twelve (12) prizes for Sunday, 27 September 2026 – Silverstone.
- 1.3 four (4) prizes for Sunday, 11 October 2026 – Brands Hatch.
- 1.4 Winners will be allocated a Prize at random.
- 1.5 The Prize will be in the form of digital tickets only and will be sent to the Winner’s email address as provided in the Toyota Trade Parts member account.
- 1.6 There is no cash alternative. The Promoter reserves the right to substitute the Prize with an alternative Prize of equal or higher value if it is necessary to do so.
- 1.7 In relation to the Prize outlined in clause 1.1, the Promoter or Administrator shall not be responsible for the condition, completeness, or content of the Prize. The Promoter and Administrator has no control over the provision or quality of the Prize and disclaims any liability for any defects, omissions, or issues arising in connection therewith.
- 1.8 The Prize is not negotiable, transferable or exchangeable.

2. ENTRY PERIOD

- 2.1 The Promotion will run from 00:00 on Friday 1st May 2026 (“Opening Date”) to 23:59 on Monday 31st August 2026 (“Closing Date”) inclusive.
- 2.2 Only invoices dated within the Opening Date and Closing Date count towards entries. All Promotion entries received after the Closing Date are automatically disqualified.

3. ELIGIBILITY

- 3.1 Subject to any other provisions of these Terms, this Promotion is open to all UK (including Northern Ireland) Independent Garages and Bodyshops who are members of the Toyota Trade Parts Club and opt into the Promotion.
- 3.2 In entering this Promotion, you confirm that your business is eligible to do so and eligible to claim the Prize you may win. The Administrator may require you to provide proof that you are eligible to enter this Promotion.
- 3.3 The Administrator will not accept entries that are:
 - (a) automatically generated by computer or created by artificial intelligence (including but not limited to chatbots such as ChatGPT or similar software applications);
 - (b) completed by third parties or in bulk;
 - (c) illegible, have been altered, reconstructed, forged or tampered with;
 - (d) photocopies and not originals;
 - (e) incomplete;
 - (f) false, misleading, fraudulent, derogatory, offensive or otherwise contrary to the spirit in which the Promotion is conducted.
- 3.4 The Promoter and Administrator reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of this Promotion.

4. HOW TO ENTER

- 4.1 The Promotion will run from 00:00 on Friday 1st May 2026 (“Opening Date”) to 23:59 on Monday 31st August 2026 (“Closing Date”) inclusive.
- 4.2 To be eligible the participant must be:
- (a) an Independent Garage or Bodyshop;
 - (b) UK company including Northern Ireland; and
 - (c) be a member of the Toyota Trade Parts Club and;
 - (d) opt into the Promotion.
- 4.3 An Independent Garage means a business that operates independently of any OEM and/or vehicle retail outlet or group, whose main business derives solely from vehicle repair and maintenance services included but not limited to MOT testing, vehicle servicing, maintenance and repairs.
- 4.4 A Bodyshop means a business whose activities derive solely or substantially from vehicle accident repair whether or not that business is independent or associated with an OEM, vehicle retailer or repairer and/or insurer.
- 4.5 The Paid Entry Route: Toyota Trade Parts Club members must opt in via <https://tradeparts-oeconnection-144780329.hs-sites-eu1.com/btcc-competition> to participate in the Promotion. One (1) prize draw entry is awarded for every £100 (excl. VAT) spent per single qualifying invoice on qualifying purchases during the Entry Period (e.g. a £500 (excl. VAT) invoice earns 5 entries) Entries accrue across the Entry Period. The Winners will be selected at random from all eligible entries submitted.
- 4.5.1 Qualifying purchases refer to the net spend across the Entry Period on genuine Toyota and Lexus parts from an Authorised Toyota Retailer which relate to service, maintenance and/or oil.
- 4.5.2 The Promotion excludes spend on parts or purchases not associated with service, maintenance for example, accessories such as tow bars and roof-racks. For the avoidance of doubt service plans are also excluded.
- 4.6 All invoices received after the Closing Date will not be counted.
- 4.7 The Free Entry Route: Toyota Trade Parts members must opt in to participate in the Promotion. To enter, participant must clearly handwrite on postcard or letter the words “Toyota Trade Parts Club Prize Draw Free Entry” together with their full name, company name, registered business address, contact telephone number and email address.
- 4.7.1 The completed entry must then be posted to us by standard first class or second-class post (at your own cost) to Toyota BTCC Competition, OEC, Construction House, Winchester Road, Burghclere, Newbury RG20 9EQ. Please ensure that postal entries are legible and complete, otherwise they will not be entered into the Prize Draw.
- 4.7.2 Please ensure that your entry is posted to us with enough time so that it is received no later than the expiry of the Entry Period. Postal entries that are received after the expiry of the Entry Period will not be processed and therefore will not be included in the Prize Draw.
- 4.7.3 You will receive one (1) entry into the Prize Draw for each individual mailing envelope, provided that you have met the requirements for the Free Entry Route set out in this section. You will only be contacted if you are a Winner.
- 4.8 By participating in this Promotion, you are agreeing to be bound by these Terms.

5. WINNER

- 5.1 The Administrator will draw sixteen (16) entries at random from all eligible entries. Each of the sixteen selected entries will win one (1) Prize, consisting of two VIP BTCC tickets (the **"Winner"**).
- 5.2 The Administrator reserves the right to allocate the Prize at its sole discretion.
- 5.3 The random selection of the Administrator is final, and no correspondence or discussion will be entered into.
- 5.4 The Administrator will contact the Winner as soon as practicable after the Closing Date using the email address provided upon application to the Toyota Trade Parts Club to notify them that they are a Winner of the Prize. It is the responsibility of the entrant to ensure they check their "junk" folder for this notification.
- 5.5 If the Administrator is unable to contact the Winner within 10 days from the first attempt to contact the Winner, a new Winner will be selected at random from all remaining eligible entries in line with the process outlined above. This process will be repeated until the Prize is fulfilled.
- 5.6 By entering this promotion, Winners agree that the Promoter may use their business name in media and marketing materials, without additional compensation, unless prohibited by law. Winners may be asked to participate in reasonable publicity related to the promotion.

6. CLAIMING THE PRIZE

- 6.1 If you are the Winner of the Prize, you will have four (4) days to claim the Prize. Instructions on how to claim the Prize will be set out in the notification e-mail received after the Winner is drawn.
- 6.2 To claim the Prize, the Winner will be required to provide their full name, email address and any dietary requirements, as well as the full name, email address and any dietary requirements of their guest. If you do not claim the Prize by this date, or fail to provide the required information within this period, your claim will become invalid.
- 6.3 The Administrator will make all reasonable efforts to contact the Winner. If the Winner cannot be contacted, or is not available, or has not claimed their Prize within 4 (four) days of the date they are contacted, the Administrator reserves the right to offer the Prize to the next eligible participant selected from the entries that were received before the Closing Date. For the avoidance of doubt, in circumstances where a replacement Winner is selected in accordance with this condition 6.2, the Administrator shall advise within the notification e-mail the number of days for the replacement Winner to claim the Prize.
- 6.4 The Promoter and Administrator do not accept any responsibility if you are not able to take up the Prize.
- 6.5 The Prize cannot be claimed by a third party on your behalf.

7. LIMITATION OF LIABILITY

- 7.1 Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the Winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the Prize except where it is caused by the negligence of the Promoter, its agents or distributors. If applicable. Your statutory rights are not affected.
- 7.2 The Promoter will not be in breach of these Terms, nor be liable for any failure to comply with any of our obligations in connection with the Promotion, if such breach or failure is caused by an event outside of our reasonable control. Events outside of our reasonable

control include, but are not limited to, acts, omissions or failure of third parties, acts of god, natural disasters, fire, flood or collapse of buildings, epidemic or pandemic, terrorist attack, war, preparation for war or armed conflict, imposition of sanctions, any law or action taken by a government or public authority, IT and data security incidents (such as malware or ransomware attacks, denial of service attacks or other types of cyber attack), or interruption or failure of utility or telecommunications service. If we are unable to run the Winner selection process within the period specified due to an event outside of our reasonable control, we will run the Winner selection process once we are no longer inhibited by such an event.

8. DATA PROTECTION AND PUBLICITY

- 8.1 The Promoter will only process your personal information as set out in the <https://www.toyota.co.uk/footer/privacy-policy> and to the extent necessary to administer this Promotion, including in the announcement of Winners, see section 5 of these Terms. Participants' personal data will be retained only for as long as necessary to administer the Promotion, notify Winners, and comply with legal obligations. After the conclusion of the Promotion and the distribution of the Prize, personal data will be securely deleted unless retention for a longer period is required by law.
- 8.2 By participating in the Promotion, you consent to the processing of your personal data for the purposes of the administration of this Promotion, including the use of third party data processors where required. Your personal data will be processed solely for the purpose of facilitating the Promotion and in accordance with our instructions and will not be shared with third parties for their own marketing purposes without your explicit consent. All third-party processors engaged in connection with the Promotion are contractually bound by data protection obligations consistent with those of the Promoter. If you have opted in to receive marketing or further information from any of the Promoter's partners or other third parties involved in the Promotion, you acknowledge and agree that those third parties will be responsible for the processing of your personal data and that such processing will be subject to their own privacy policies. The Promoter accepts no responsibility for how third parties process your data, and any queries or concerns should be addressed to them directly.
- 8.3 The Promoter must either publish or make available information that indicates that a valid award took place. To comply with this obligation, the Promoter will send the surname and county of the Winner and, if applicable, copies of their winning entries to anyone that requests this information and emails Toyota@tradeparts.oconnection.com or writes to Toyota (G.B.) - 8.4 If you object to any or all of your surname, county and winning entry being published or made available, you can restrict the processing of your personal data by emailing the Promoter at toyota@tradeparts.oconnection.com. In such circumstances, the Promoter must still provide the information and winning entry to the Advertising Standards Authority on request.

9. GENERAL

- 9.1 If there is any reason to believe that there has been a breach of these Terms, the Promoter, at its sole discretion, reserves the right to exclude you from participating in the Promotion at any stage.
- 9.2 The Promotion may be varied, amended, extended or withdrawn at any time.
- 9.3 No third party can enforce these Terms.

- 9.4 In the event of a conflict between these Terms and any other Terms or instructions related to this Promotion, these Terms take precedence.
- 9.5 These Terms are governed by English law and are subject to the exclusive jurisdiction of the English Courts.
- 9.6 The Promoter may transfer our rights and obligations under these Terms and the Promotion to any of our affiliated companies, or to any third party in connection with our business.
- 9.7 The Prize Draw is not a charity lottery or raffle. Please note that the Prize Draw is not a lottery as defined under the Gambling Act 2005, because we offer a Free Entry Route by post in addition to the Paid Entry Route.
